E & K Farms, LLC and it’s staff take pride in having available to you, as a horse owner, tenant, guest, licensee, or invitee on the premises a clean, safe, affordable place to board and enjoy horses and the “horse environment”. We have taken all reasonable steps to inspect and repair known defects to the building structures and grounds. Unfortunately, through unforeseeable misuses or events beyond our control, a potentially dangerous or harmful condition may arise on the property and may result in injury or economic loss before we reasonably could have been expected to know of the situation and correct it. We ask that you report any concerns you may have about potentially unsafe conditions to a member of the staff, so that we may promptly investigate and correct for potential hazards. We do not assume responsibility for your personal property and its use while on the Farm or in our custody or control. When you enter or use the facility, you assume the risk of injury or damages, and you knowingly accept this risk. _____

The Farm is not responsible for any bodily injuries or property damage you may sustain while visiting or using our facilities. In exchange for our permission to visit or use the facilities, you release, acquit, discharge, and indemnify E & K Farms and it’s owners, Eric & Kelly Hamilton, staff, managers, and employees from any and all claims, demands, actions, or causes of action, whether or not foreseeable, arising out of the use of our facilities, including but not limited to: general and special damages arising from bodily injury, property damage, or emotional distress. This release applies to all activities you engage in on our property or while in our facilities, whether those activities are under the direction of a trainer or staff member or whether they are self directed. _____
